## CONDITIONS AND REGULATIONS

Governing the issuance of the Permit Contained on the Reverse Side

1. This permit is not valid unless signed by the Director of the Parks & Recreations Department or his designated appointee(s).
2. This permit is not transferable or assignable.
3. In the event of cancellation of this permit, by the Permit Holder, written notice must be given to the Parks & Recreation Department one week (7 days) in advance of the activity or 45 days in advance of a special event or a social function.
4. The Parks & Recreation Department may cancel this permit upon notice at any time, notice of cancellation is deemed to be in effect immediately upon notice either verbally or in writing.
5. If the Parks & Recreation Department desires to cancel this permit while the facility is being used by the Permit Holder, notice of cancellation is sufficient if verbal cancellation is given by the Director of the Parks & Recreation Department or his appointee(s) to the Permit Holder, or any person in authority, while the facility is being used.
6. If a permit is not granted by the Parks & Recreation Department the applicant may request the Council of the Corporation of the City of Burlington, through the Community & Corporate Service Committee, to consider the request and if the Permit Holder, or an agent of the Permit Holder, wishes to make personal representation to the Community & Corporate Service Committee, City procedure must be followed.
7. The facilities for which this permit was granted shall be used only on the date(s) and time(s) specified.
8. By-Law No. 2741 – “Being a by-law to provide for the maintenance, protection, use, regulation, control and enjoyment of all the lands and properties owned by and in the City of Burlington for park purposes” – and any subsequent amendments thereto, is an integral part of the conditions and regulations under which this Permit is granted and shall be adhered to in every respect. (By-Law No. 2741 may be viewed or a copy obtained at the Recreation Office).
9. (a) The City of Burlington does not accept any responsibility for personal injury or death of any person, or damage, or for the loss or theft of any article of clothing, personal belongings or equipment of the applicant or organization, or for anyone in attendance, and by applying for this Permit the applicant and the Permit Holder hereby waive all such claims as against the City.  
  
(b) The applicant and the Permit Holder hereby agree to indemnify and save harmless the City of Burlington against all claims whatsoever, and upon request of the Director of the Parks & Recreation Department or his appointee(s) will lodge with the City a liability insurance policy in a form and in an amount satisfactory to the City of Burlington.
10. All privately owned property and personal effects must be removed without delay unless prior arrangements have been made with the Parks & Recreation Department.
11. The applicant shall pay for all damages to facilities arising out of the use of such facilities granted by this permit: facilities include land, turf, building, fixtures, and/or chattels.
12. The Parks & Recreation Department does not accept responsibility for costs incurred by the Permit Holder due to malfunctions or problems incurred beyond our control.
13. No fee may be charged by the Permit Holder for the use of any facilities unless the particulars of the same are set out in the permit and have first been approved by the Director of Parks & Recreation or his appointee(s).
14. All permit holders must comply with Federal and Provincial laws and Municipal by-laws and resolutions, including those respective the use of alcoholic beverages.
15. The Permit Holder is prohibited from selling or distributing articles in any facility or park without prior consent from the Director of Parks & Recreation or his appointee(s).
16. Maximum attendance at any facility shall be governed by the Fire Regulations and all exits must be kept free from obstructions at all times.
17. Any person who has in his possession any intoxicating liquor or alcoholic beverage, or who appears to be impaired will be removed from the facility.
18. Smoking is prohibited in all City Facilities as per By-Law 46-1992, unless otherwise posted.
19. Permit Holders must use parking areas when they are provided and are requested to encourage spectators and the general public to do likewise when viewing activities granted by this permit.
20. Open fires for any purpose are prohibited in Burlington parks. Permit Holders of picnic sites are required to use camping stoves or barbecues.
21. All activities must be conducted in a sportsmanlike and orderly manner.
22. The use of profane language is prohibited.
23. All rentals must be paid for in advance.
24. No one is allowed on ice while resurfacing machine is in operation.
25. This permit holder must be 18 years of age or older and must be present for the duration of time(s) as outlined on the permit.
